Financial Aid PASSWORD

Description: This session will model the gameshow PASSWORD. Two teams of two individuals, one being a 'celebrity' or in our case, a very seasoned FAA (maybe our OASFAA President?) and the other a random conference attendee. Utilizing the FSA Handbook Glossary, terms are selected as the secret password. The password is then shared with the audience and with one member of the two teams. The team member with the password attempts to describe the password with one word and they can not use the password. The other team member attempts to guess the password. If one team fails at the attempt, the other team is provided the opportunity to guess the password. Teams take turns attempting to guess the password with a limit of 9 attempts. If a team guesses the password with the number of attempts, that team earns points. The team with the most points at the end of the session wins.

Federal Session: Verification 2021-22 and 2022-23

Description: This session will include a discussion of the verification requirements for the 2022–23 Free Application for Federal Student Aid (FAFSA®) cycle and review verification issues related to the 2021–22 FAFSA cycle.
