

#### **Oregon Financial Aid Overview**

What types of financial aid can undocumented/DACA students receive?

- Oregon Opportunity Grant
- Oregon Promise Grant
- Foster Youth/Youth Experiencing Homelessness Tuition Fee Waiver
- Scholarships
- Institutional Aid

#### **Oregon Opportunity Grant**

- Largest need-based state grant
- Submit ORSAA as soon as possible after it opens and meet SAI limit
- Must live in OR for 12 months and meet all 4 specific criteria:
  - 1. Attend K-12 school in <u>US</u> for 5 years prior to graduation
  - 2. Attend K-12 school in <u>OR</u> for 3 years prior to graduation
  - Graduate from an Oregon high school (or equivalent)
  - Intention to become citizen or legal permanent resident

#### **Oregon Opportunity Grant**

#### **In-State Tuition & Additional OOG Eligibility Requirements**

Undocumented students may be eligible for in-state tuition rates at public universities as long as they meet the additional eligibility requirements listed below. To apply, undocumented students must either:

- Complete an Affidavit and Request for Exemption from Nonresident Tuition and Fees, available at the Admissions Office of each Oregon public university; OR
- Submit an official copy of application for registration with a federal immigration program or federal deportation deferral program.

#### **Eligibility Requirements**

To be eligible for in-state tuition rates as well as the <u>Oregon Opportunity Grant</u>, undocumented students must meet all of the following tuition equity requirements:

- Student attended an elementary or secondary/high school in Oregon during all three years immediately prior to earning a high school diploma or leaving school before earning a diploma
- Student attended an elementary or secondary/high school in the United States for at least five years immediately prior to earning a high school diploma or leaving school before earning a diploma
- · Student received a high school diploma or GED® in Oregon
- · Student certifies intention to become a U.S. citizen or lawful permanent resident

#### **Oregon Promise Grant**

- For new/recent high school graduates and GED® test graduates
- Only for Oregon community colleges
- Submit ORSAA & complete OPG application by appropriate deadline
- Student (and parent) must live in Oregon for at least 12 months — No other residency requirements

## Foster Youth/Youth Experiencing Homelessness Tuition Fee Waiver

- •Were in the care and custody of DHS, or one of the nine federally recognized Tribes in Oregon. Former or current foster youth who spent at least 180 days (6 months) in substitute care after age 14, AND did not leave substitute care and custody of (DHS or Tribe) prior to their 16th birthday;
- •Adopted former foster youth who spent at least 180 days (6 months) in substitute care and were adopted on or after January 1, 2012; or
- Experienced homelessness for at least 180 days (6 months)
   between ages 14 and 24 years old and meet the following requirements:
  - While experiencing homelessness, received services from an organization contracted by DHS or a host home; AND
  - Was at least 16 years of age when last receiving services

#### Scholarships & Institutional Aid

- Wide variety of privately funded scholarships available - including over 80% of OSAC Scholarships
- Colleges and universities may have additional financial aid available. What is your scholarship application process for institutional scholarships?


 Not sure which application to complete? Start with the prefilter tool for all students.

 After student e-signs, they must send parent an invite via email

 Parent checks email, creates account, reviews & e-signs

### ORSAA Tips to Complete the ORSAA

Submitting a revision, adding a college, etc.



Student should FIRST download
 PDF of the ORSAA

 Student will need to re-enter financial information

Be sure to e-sign again!

### ORSAA Communication Tools

- OSAC emails students within 1-2 weeks to confirm ORSAA submission.
- OSAC emails students about potential errors on their submitted ORSAA.
- Completed PDF of ORSAA shows the student's SAI. (Student can request letter from OSAC.)

### ORSAA Awarding Information

- Awarding email notification for Oregon Opportunity Grant typically starts in March/April (if student is awarded).
- Students should complete other aid applications (OSAC Scholarships, Oregon Promise, campus, etc).

### ORSAA Resources



The ORSAA is the alternative to the Free Application for Federal Student Aid (FAFSA) for undocumented students in Oregon, including students with Deferred Action for Childhood Arrivals (DACA) status. The ORSAA gives students access to state grants and scholarships.

#### WHO SHOULD SUBMIT AN ORSAA?

You should submit the ORSAA if you're an undocumented student, including DACA, TPS, or U-Visa status, and you are a new or continuing college student.

You must currently live and study in Oregon.

WHY SHOULD I SUBMIT AN ORSAA? By submitting the ORSAA - early, and each year you attend college - you can gain access to financial aid through the state of Oregon such as

the Oregon Opportunity Grant, Oregon Promise Grant\*, and OSAC Scholarships\*. You must meet eligibility criteria for each program. Financial aid helps you meet the costs of attending college.

\* You must complete additional applications for these opportunities by the deadline

#### DO I NEED TO SUBMIT THE ORSAA AND THE FAFSA?

First, submit the ORSAA if you are an undocumented, DACA, TPS, or U-Visa student. Next, talk to the financial aid office at your school. Ask if you can complete anything else to apply for

#### WHAT DO I NEED IN ORDER TO SUBMIT

You should gather the following information for yourself (and your parent(s) or spouse if applicable):

- Different email address for student and parent(s)
- Date of birth, phone number, address
- Tax return and/or other income information from two years prior
- Bank statements, records or untaxed income, and/or records of investments

HOW DO I SUBMIT THE ORSAA? The ORSAA is always free to submit. Visit the OSAC website and file online: OregonStudentAid.Gov/fafsa-orsaa

WHEN DO I SUBMIT THE ORSAA? Submit the ORSAA as soon as possible after October 1st each year. For the 2024-25 ORSAA only, the application will open in December 2023.

Usted debe actualmente vivir y estudiar en Oregón.

#### ¿POR QUÉ DEBO SOMETER LA ORSAA? Al entregar la ORSAA – temprano, y cada año que asiste a la universidad-usted puede obtener acceso a la ayuda financiera a través del estado de Oregón, como Oportunidad de Oregón, Promesa de Oregón\*, y becas de OSAC\*. Usted debe cumplir con los criterios de elegibilidad para cada programa. La ayuda financiera le ayuda a cubrir los
