## **Volunteer Spotlight: Ryan West**


The OASFAA Volunteer Spotlight shines on Ryan West, the Financial Aid Director at Chemeketa Community College.

Volunteer activities with OASFAA: Wow – there have been a lot. I've been Treasurer, VP, President, Conference co-chair, FA 101/201 co-chair, Archives chair, OPB Financial Aid for College Night and on various committees throughout the past 20 years. I may have been the secretary one year too but I'm a terrible notetaker so hopefully I wasn't.

How long have you been in financial aid? Started January 2, 2002

How did you get your start in financial aid? When I was a student at Western Oregon University, I worked for the Vice President for Student Affairs. Prior to being a VP, he was the Director of Financial Aid (Michael Cihak for any other ancient OASFAA people out there). Our office shared a copy machine with financial aid because Michael was too cheap to get us one. So my job often required me to go to financial aid and copy things. Over the course of a couple years, I got to know the people in the WOU financial aid office. After I graduated from WOU, I worked as an Auditor for Grant Thornton in Portland and was miserable. A financial aid counselor position came available at WOU, I applied, and was hired.

What is the most rewarding part of your job? Even amidst the thick bureaucracy in which we work, I still get the sense that the work we do matters. It helps transform lives from poverty. It helps people achieve their career and college dreams. It feels like it is work that improves lives and that is deeply rewarding to me. (Volunteer...continued on page 3...)

# case/student will you be most likely to remember for the rest of your

life? When I was a financial aid counselor at WOU, with maybe 1-2 years of experience, I met with a nontraditional aged woman. She was bald from finishing chemo treatments, had a young child with her and had told me how her husband had left her and her business had failed and she faced cancer treatments all in the past year and had decided she needed to go to school to have a brighter future. I went over the paltry financial aid offer we could give her (she applied late so missed the Oregon Opportunity Grant and our campus-

based aid) so basically, she had freshman-level loans and a Pell Grant – not enough to support her education let alone a family trying to survive. She was wildly disgusted with what I had to offer and made her displeasure known. She stormed out of my office frustrated and showed back up about 15 minutes later and told me she was going to do it anyway. She did it – she earned a bachelor's and a master's degree at WOU and became a teacher. I visited her school for an unrelated meeting several years ago and reconnected with her. She has thrived as a teacher; her health is good and her kids are grown. She's happy and made quite the impression on me!

What is the most difficult aspect of your job? The pace of change is so slow in academia in general, including financial aid. It can be frustrating when it seems like there could be simple changes to make education financing more accessible to more students, but we're stuck with old-school rules for an old-school education model that often fails our students.

How do you cope with stress on the job? Laughter – I like to laugh at the absurd things (and people) in life. Eyerolling and swearing also seem to help.

Who has been the biggest influence/mentor on your career? There have been so many. The biggest influencers/encouragers for me, especially regarding OASFAA, were my first two bosses in financial aid – Sandy Mountain and Donna Kirk. They both supported me in getting involved in OASFAA as a newbie and Donna especially was so great at introducing me to amazing colleagues in the financial aid profession. I've benefitted in the course of my career by hanging around with people much smarter than me who astonishingly are willing to respond to my many questions – Mike Johnson, Kathy Campbell, Peter Goss, and Breana Sylwester to just name a few. I'd love to be an author or landscaper – not sure I'd be particularly good at either but those have always stood out to me.




